### 1. GTAP Model and Data Base Usage

In addition to the usual update of CEPII's tools (the MIRAGE-e model, the MacMap tariff database), which are to be published in the coming months, this year has been marked by questions about protectionism, and in particular Brexit and the US trade policy. In addition, the CEPII has pursued its contributions to the fields of non-tariff measures (technical barriers to trade), agri-food trade (food safety, trade liberalization), free trade agreements (Sub-saharan Africa, CETA) and climate change mitigation (Paris agreement, impact of FTAs).
